### **ROAD CLOSURES AND POSSIBLE TRAFFIC DELAYS**

SUFFOLK, VA (January 30, 2012) The following roads in the City of Suffolk will have closures and possible delays today, Monday, January 30, 2012, due to construction and maintenance projects:

-A contractor will have possible flagger operations with single lane closures in the 4300 to 5200 block of Godwin Boulevard from 9 a.m. until 3 p.m. every Tuesday through Friday. The work is expected to be ongoing through March 2012.

-A contractor will have possible shoulder and lane closures in the 3800 block of Bridge Road to conduct construction projects for the Bridge Road Medical Office Complex. This project is expected to be ongoing until March 2012.

-A contractor will be performing utility work requiring various lane closures on West Washington Street. The work will run from 9:30 a.m. until 3:30 p.m. during business days until February 3, 2012. The closing of the westbound lane and parking lane of West Washington Street will occur during phase one and the closing of the eastbound lane and parking lane of West Washington Street will occur during phase two. Roadway signage will be displayed to direct traffic detours for the project duration.

-The City of Suffolk Department of Public Works will have one lane closed on Garfield Avenue between Harrison Street and Pitchkettle Road until 3 p.m.

-A contractor may have periodic shoulder and lane closures in the 4600 to 4900 blocks of Sleepy Hole Road on the southbound side due to an ongoing project. The work is expected to last until April 2012.

-CSX Railroad will have Pine Street closed at the railroad crossing until 6 p.m. The railroad crossing on Buckhorn Drive will be closed today, January 30, 2012, and tomorrow, Tuesday, January 31, 2012. Additionally, the crossing on Kingsale Road will be closed Tuesday, January 31 through Wednesday, February 1, 2012. CSX Railroad anticipates total completion and removal of detours within the Suffolk City limits by the end of this week, weather permitting. Proper detour signage will be displayed to direct traffic during the project.

-Contractors will have the outer westbound lane of Route 58 closed from Kenyon Road to Manning Bridge Road from 7:30 a.m. until 4:30 p.m. to provide a safe work zone. This closure is for the installation of new water and sanitary sewer improvements. The work is scheduled for completion in early May 2012.

-A contractor is conducting work at the intersection of Nansemond Parkway and Shoulders Hill Road. Delays are possible in this work zone.

-A contractor will begin repair work on the Mills Godwin Bridge in the northbound direction. Due to the work, there will be short durations of flagging operations during the day as well as at night which will require a shifting of lanes onto the shoulder of the bridge to minimize impact to traffic. Two lanes of traffic will be open at all times. Phase one of this project is scheduled to be completed by March 1, 2012, weather permitting. Phase one repair work will include total reconstruction of the expansion dams and resealing of the expansion joints along the entire 4000 linear foot bridge.

-The City of Suffolk Department of Public Utilities Line Maintenance Division will have the southbound lane of North Broad Street closed from Second Avenue to West Washington Street from 9 a.m. until 3 p.m. due to utility work. Southbound traffic will be detoured at Second Avenue and traffic heading north on North Broad will flow as normal.

-The City of Suffolk Department of Public Works will have a mobile right lane closure on Route 58 westbound between Route 189 and the Southampton County line until 3 p.m.
